The Nigerian Equity Market closed today's trading session **BEARISH** leading to a **0.12%** decrease in the **All-Share Index**. This resulted in a year-to-date return of **2.79%**. Consequently, the market capitalization settled at **66.50trn**.

The market movers were the stocks of GTCO, ACCESSCORP, ZENITHBANK, UBA and MTNN etc.

Market Breadth which is the measure of investors' sentiment was **1.54x** compared to the previous day's market breadth of **1.65x**

## GAINERS & LOSERS, VOLUME&VALUE DRIVERS, COMMODITIES RATES

The total number of advancers was **37**, chiefly led by stocks of **UPL**, **VITAFOAM** and **LIVESTOCK** with **10.00%**, **10.00%**, and **9.97%** gains each. Whereas, the number of decliners stood at **24** led by **ETI**, **INTBREW** and **IKEJAHOTEL** with **10.00%**, **10.00%**, and **9.89%**, loss respectively. The Volume and Value drivers of the day's market trend were led by stocks of **UBA**, **WEMABANK** and **MTNN**.

Transaction Volume for the day recorded **393 million**, compared to the previous day's volume of **733.05 million** trades valued at **\mathbb{H} 12.75 billion** from the **17,519** deals executed. The number of stocks engaged at the end of today's trading session closed at **129.** 

At the time of writing this report, **Brent Crude** was trading at \$63.32/barrel, **WTI** at \$59.49/barrel, **OPECBASKET** was trading at \$68.18 barrel while Gold was trading at \$3,311.18/ounce on the international Commodities Market. The U.S Dollar Index which is a measure of the value of the U.S. dollar relative to a basket of foreign currencies, closed at 99.27 index points.
