
NIGERIA EQUITY MARKET


The Equity market experienced a total turnover of 2.645 billion shares worth N77.005 billion in 86,110 deals was traded this week by investors on the floor of the Exchange, in contrast to a total of 2.200 billion shares valued at N75.409 billion that exchanged hands last week in 70,329 deals.

The Financial Services (measured by volume) led the activity chart with 1.638 billion shares valued at N45.825 billion traded in 37,843 deals; thus contributing 61.90% and 59.51% to the total equity turnover volume and value respectively.

The Services industry followed with 364.653 million shares worth N2.909 billion in 7,760 deals. Third place was the Consumer Goods Industry, with a turnover of 190.221 million shares worth N6.771 billion in 10,595 deals.

Trading in the top three equities namely Guaranty Trust Holding Company Plc, Access Holdings Plc and Tantalizer Plc (measured by volume) accounted for 839.689 million shares worth N27.737 billion in 8,898 deals, contributing 31.74% and 36.02% to the total equity turnover volume and value respectively.
